No commission will be added to the final price.

The buyer must show an official identification or passport to before to sing the sold contract.

Gobierno del Estado de Chihuahua is the responsible for the delivery of the endorsed invoice.

**Aircrafts Delivery**

- Agreement on delivery of the aircraft will be made only after paid in full.
- After the purchase contract sign, the buyer must to pick up the aircraft immediately or in a term no greater to 30 natural days, if the buyer exceeds the indicated term, will have to pay \$1,000.00 (thousand pesos) per each exceeded day.

- The purchaser or buyer will have to fulfill import or export process and payments according to the country destination law.
- Gobierno del Estado de Chihuahua could delivery the aircrafts in any border point of México-USA, if the buyer is agree to pay all the transportation costs.
